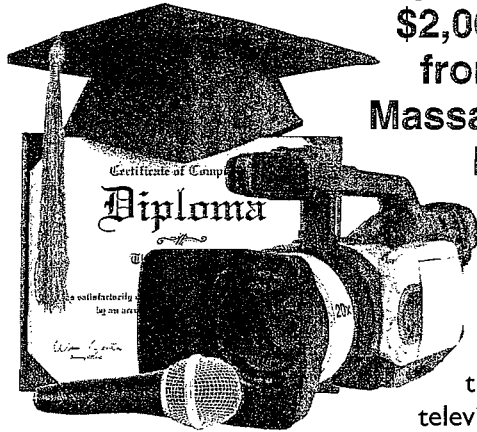

Description of Activity and Station Participation:

Tom Wall, General Manager of WCTK/WNBH/WLKW participated in the selection and awarding of five two thousand dollar scholarships to area youths pursuing careers in broadcasting. The Massachusetts Broadcasters Association received many applications. In addition to a cash donation to the scholarship fund WCTK/WNBH/WLKW helped publicize The MBA Student Broadcaster Scholarship Program. WCTK/WNBH/WLKW aired 540 sixty second announcements over a nine week period. (script and proof of announcement attached) WCTK/WNBH/WLKW also made applications available at our reception desk throughout the application period for any students requesting an application. (Application attached) The finalist were reviewed by Tom Wall and ranked from one to ten. Scores were compiled by the MBA and five winners were chosen to receive scholarships.

Students interested in a career in over-the-air broadcasting are encouraged to apply for a \$2,000 scholarship from the Massachusetts Broadcasters Association.

Our Association is committed to encouraging students who are interested in the radio and/or television industry to enroll as a secondary education student to further their education.

Who is the Massachusetts Broadcasters Association?

Established in 1954, the Massachusetts Broadcasters Association is a non-profit trade association for over-the-air radio and television stations in Massachusetts. Its purpose is to pursue the best interests of the broadcast industry within the Commonwealth by helping to create an economic and regulatory environment conducive to the growth of broadcasting and its service. Alongside supporting those already in the industry, the Massachusetts Broadcasters Association aims to promote broadcasting as a viable and opportunistic career choice.

Who should apply for the Student Broadcaster Scholarship?

Students who are permanent residents of Massachusetts and are in the process of enrolling, or are currently enrolled, at an accredited institution of higher learning are encouraged to apply. Such institutions include vocational schools, 2- or 4-year colleges or universities offering degrees in radio and television broadcasting. Applying students must meet their school's status of a full-time student. The school does not need to be within the Bay State.

How will award recipients be selected?

The selection process for scholarships will take into account such factors as financial need, academic merit, community service, extra-curricular activities, and work experience. Highest priority will be given to students with the most limited financial resources. Student applications are reviewed and selected by broadcasters who are participating members of the Massachusetts Broadcasters Association Student Broadcaster Scholarship Program.

How and when are awards disbursed?

Scholarship payments will be made payable to both the student and the school and will be awarded in time for the '09 fall semester. Students receiving a scholarship will be contacted by phone and a check presentation will be arranged at a station in their neighborhood. Letters of regret are sent to those students who have not been awarded aid.

What is the application process?
